ORDINANCE NO. 2009-26**

**AN ORDINANCE OF THE CITY OF ST. PETE BEACH FLORIDA PROVIDING FOR AMENDMENT OF APPENDIX A, SECTION 82, FEE SCHEDULE OF THE CODE OF ORDINANCES, AS SET FORTH IN ATTACHMENT APPENDIX "A" TO THIS ORDINANCE; PROVIDING FOR PARKING PERMIT, PARKING DECAL FEES , AND; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith TO THE EXTENT OF SUCH CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the City Commission wishes to update the City's fees pertaining to the City's parking permits and parking decals; and

WHEREAS, the City Commission has found that this Ordinance to be in the best interest of the health, safety and welfare of the citizens of the City of St. Pete Beach;

**NOW THEREFORE, THE CITY COMMISSION OF THE CITY OF ST. PETE BEACH, FLORIDA DOES HEREBY ORDAIN:**

Section 1. Appendix A, Section 82 of the Code of Ordinances, City of St. Pete Beach, Florida is hereby amended as set forth in attachment "A" to this Ordinance.

Section 2. If any portion, part or section of this Ordinance is declared invalid, the valid remainder hereof shall remain in full force and effect.


Section 3. All ordinances, or parts of ordinances, in conflict herewith, are hereby repealed to the extent of such conflict.
