ORDINANCE NO. 2009-27**

**AN ORDINANCE OF THE CITY OF ST. PETE BEACH FLORIDA
PROVIDING FOR AMENDMENT OF CHAPTER 82, ARTICLE III,
DIVISION 2, SECTION 82-171, FINES FOR VIOLATIONS;
PROVIDING FOR SEVERABILITY; PROVIDING FOR THE
REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN
CONFLICT HEREWITH TO THE EXTENT OF SUCH
CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the City Commission wishes to update the City's fines for certain violations pertaining to the City's parking regulations; and

WHEREAS, the City Commission has found that this Ordinance to be in the best interest of the health, safety and welfare of the citizens of the City of St. Pete Beach;

NOW THEREFORE, THE CITY COMMISSION OF THE CITY OF ST. PETE BEACH, FLORIDA DOES HEREBY ORDAIN:

SECTION 82-171 FINES FOR VIOLATIONS

Section 1. Chapter 82, Article III, Division 2, Section 82-171 of the Code of Ordinances, City of St. Pete Beach, Florida is hereby amended as follows:

82-171: Fines for violations:

(1) Overtime Parking	\$20.00	<u>\$25.00</u>	<u>\$40.00</u> <u>After 15 days</u>
