ORDINANCE NO. 2010-06

AN ORDINANCE OF THE CITY OF ST. PETE BEACH FLORIDA PROVIDING FOR AMENDMENT OF CHAPTER 82, ARTICLE II, DIVISION 1, SECTION 82-31, ONE WAY STREETS; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith TO THE EXTENT OF SUCH CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission wishes to improve the traffic flow regulations pertaining to city streets; and

WHEREAS, the City Commission has found that this Ordinance to be in the best interest of the health, safety and welfare of the citizens of the City of St. Pete Beach;

NOW THEREFORE, THE CITY COMMISSION OF THE CITY OF ST. PETE BEACH, FLORIDA DOES HEREBY ORDAIN:

**SECTION 82-31 ONE WAY STREETS**

**Section 1.** Chapter 82, Article II, Division 1, Section 82-31 of the Code of Ordinances, City of St. Pete Beach, Florida is hereby amended as follows:

**82-31: One Way Streets:**

The following streets, roadways and avenues shall be designated as one way.

- (1) East Maritana Drive between 35th Avenue and 36th Avenue.
- (2) 22nd Avenue west bound between Gulf Way and Pass-A-Grille Way.
- (3) 16th Avenue west bound between Gulf Way and Pass-A-Grille Way.
- (4) 15th Avenue east bound between Gulf Way and Pass-A-Grille Way.
- (5) 9th Avenue east bound between Gulf Way and Pass-A-Grille Way.
- (6) El Centro south bound between 37th Avenue and 35th Avenue.
- (7) **10<sup>th</sup>. Avenue westbound between Pass A Grille Way and Gulf Way.**

**Section 2.** If any portion, part or section of this Ordinance is declared invalid, the valid remainder hereof shall remain in full force and effect.

**Section 3.** All ordinances, or parts of ordinances, in conflict herewith, are hereby repealed to the extent of such conflict.

**Section 4.** This ordinance shall become effective upon final adoption as provided by law.
