A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF ST. PETE BEACH, FLORIDA PROVIDING FOR REIMBURSEMENT OF ATTORNEYS FEES TO OR ON BEHALF OF COMMISSIONER BEVERLY GARNETT; MAKING FINDINGS AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Commissioner Beverly Garnett has submitted a request for reimbursement of attorneys fees and costs incurred or owed by her as a defendant in the case of Kadura v City of St Pete Beach, Case No. 08-12498-CI-19; and

WHEREAS, This Commission hereby finds that the complaint against Commissioner Garnett as described above arose from the performance of her official duties while serving a public purpose; and

WHEREAS, Commissioner Garnett has complied with city policy for such reimbursement; and

WHEREAS, The City Attorney has reviewed the request and supporting documentation and has determined that Commissioner Garnett has satisfied the requirements for such reimbursement and that the amount requested is reasonable.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ST PETE BEACH:

Section 1: AUTHORIZATION OF REIMBURSEMENT OF ATTORNEYS FEES: The City Manager is authorized and directed to reimburse

attorneys fees and costs to or on behalf of Commissioner Beverly Garnett in the total amount of \$4,254.48.

Section 2:            EFFECTIVE DATE:    This Resolution shall take effect immediately upon its adoption by the Commission.
